The **Direct Debit** Guarantee



- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit Squarefoot Self Storage Ltd will notify you 5 working days in advance of your account being debited or as otherwise agreed. If you request Squarefoot Self Storage Ltd to collect a payment, confirmation of the amount and date will be given to you at time of the request.
- If an error is made in the payment of your Direct Debit, by Squarefoot Self Storage Ltd or your Bank or Building Society, you are guaranteed a full and immediate refund from your bank or building society.
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
